## REQUIREMENTS:

- a) One month of crossings in advance.
- b) Each AVI costs \$16.00.
- c) Payment can be done with check, cash or money order.
- d) How many AVI's are needed?
- e) Total axels per truck (minimum and maximum).
- f) Economic or unit number, or licenses plate number so that the vehicle is identified.
- g) A copy of the RFC or license of the driver for each vehicle that will have an AVI.
- h) A username and password is given when the account is opened, so that you can check your account on line.
